The Mission of the Kickapoo Tribe Nutrition Program is to assist all Kickapoo Tribal elders by providing a nutritious lunch and on specific days, breakfast.

We serve lunch for all Elders 50 years and older. There is a \$3 charge for those who are 49 years and under.

Monday - Thursday

7am-11am.....Preparing Food
 12pm-1pm.....Serve Lunch
 10:30-1:30.....Delivering Meals to elders
 1pm-3pm.....Cleaning

Friday NO Deliveries on Friday!

6am-8am.....Preparing breakfast
 9am-10am.....Serve Breakfast
 10:30-3:00.....Clean

➢ We also provide transportation for Elders to pay utility bills and go to the grocery store.
 ➢ We serve about 3 or 4 traditional meals a month.
 ➢ On some occasions the elders play bingo.
 ➢ During Holiday seasons the Nutrition Provides a Thanksgiving and Christmas Dinner.
 ➢ During the summer time we have a couple cookouts .
 ➢ In some instances the elders go on different activities together
 ➢ The Nutrition also provides the facility to be used for fundraisers and other activities upon the directors approval
